AGREEMENT OF RELEASE

No owner, driver, contestant or representative thereof shall hold any other owner, driver, contestant or representative thereof liable for any personal injuries or damage resulting from an accident of racing occurring in a CDBA race, except as a result of deliberate collision or other premeditated acts of unsportsmanlike nature. The question as to whether the act was deliberate or premeditated shall be determined by the Referee subject to review by the appropriate Racing Commission.
